In the event of any discrepancy between the original Hebrew and the translation to English, the Hebrew version alone will prevail.

No later than one business day following the conference calls, the Company will publish a link to a website where recordings of the calls will be available. The Company intends to publish, shortly prior to the conferences, a presentation regarding the Company, which will be presented during the conferences.

The conferences do not replace the need to review the Company's immediate and periodic reports and the presentations published by the Company from time to time, which include full information regarding the Company's activities, including forward-looking information contained therein, in accordance with Section 32A of the Israeli Securities Law, 5728-1968.
